3. **Grading:**

In determining the overall grade in the course the following weights will be used:

The take-home midterm exam will be open book and it is to be completed during a 48-hour period at the students' place of choice. Submission will be online and instructions will be given to students during class before the start of the 48-hour period. Individual work is required.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.
